**Institutional License Agreement for Electronic Distribution**

Upon purchase of a download of *APA Style Guide to Electronic References*, Sixth Edition (hereinafter, "Licensed Material") in .pdf format, **apa** (hereinafter, Licensee) is granted the right by the American Psychological Association (hereinafter, Licensors) to distribute it via electronic means, subject to the following terms and conditions:

Subject to all terms and restrictions hereinafter set forth, the Licensors hereby grants to the Licensee the nontransferable and nonexclusive access to Licensed Material.

Licensee may make Licensed Material available to Authorized Users via a secure network (whether a standalone network or a virtual network on the Internet), which is accessible only to Authorized Users who are approved by the Licensee and whose identity is authenticated at the time of log-in and periodically thereafter consistent with current best practice and whose conduct is subject to regulation by the Licensee.
